

2022 LICENSING FEES

The listing below reflects the official order of WISSOTA divisions. If you are applying for rookie status in any division (by checking the blank on the front of this license form), then you are stating that you have not raced more than five (5) shows in that division, or any higher division, within WISSOTA or at any other track or in any other sanction, in previous years (cumulative). If it is later discovered that you did not meet this qualification, your rookie status for any potential awards will be denied.

Drivers: Please be sure that entire form is <u>completely</u> filled out and <u>readable</u> before submitting to your track or to WISSOTA for license approval. If form is not complete, not readable, or if incorrect payment is received, the form will be returned to you for correction; your licensing to race will be delayed, as will your subscription to All The Dirt! and your participant accident insurance policy coverage. Do <u>NOT</u> wait to buy your license at the track - order online for best and fastest service.

No driver may purchase a Hornet division license if they have ever raced in the Super Stock or any higher division. Any driver who has raced in the Midwest Modified division or lower class, for one season or less, or has not raced in the past five years, may purchase a Hornet division license. A Hornet driver may also hold a license in the Pure Stock division only. Any driver who has won a national championship in any class (or two in Hornets), is ineligible to purchase a Hornet license. If you are found to have violated this restriction, WISSOTA retains the right to cancel your Hornet license, and you will not be eligible for any refund of your license fee. TEMPORARY LICENSES: Valid For 1 (One) Event Only Late Model, Modified, Super Stock Midwest Mod. Street Stock, Mod Four: \$55 • Pure Stock & Hornet: \$25 There will be no "upgrades" allowed from a temporary license to a full license. Temp licenses can only be purchased at the track on race night. Temporary licenses do not include any driver insurance coverage or a subscription to All The Dirt.
